\*\*\* PARENTS: If you bring children to the show, you are responsible for where they are and what they are doing at all times. You will be held financially responsible for any damage they may cause. If your children are unsupervised or acting in a manner which could cause harm to themselves, to others, or to property, you may be asked by the Show Officials to leave. Your entry fee will be forfeited and entry eliminated.

Any exhibitor attempting to, actually interfering with, annoying or influencing a judge, or acting in a manner unbecoming an exhibitor may be ejected from the show with entry fees forfeited.
