Daviess County Lions Fair Grounds 6191 State Route 54, Philpot, KY 42366

From Louisville KY: Take I-64 West. Take Exit 57 US-231 south toward Kentucky. Turn LEFT onto US-231 S/US-60 BYP W (McDonald, Rural King at the corner). Take first EXIT-18 to KY-54, turn LEFT toward Whitesville/Leitchfield. Go 5.4 miles on KY -54. Daviess County Fair Grounds is on the left.

From Nashville TN: Take I-65 North, Take William H Natcher Pkwy N via Exit 20 toward Bowling Green/Owensboro. Merge onto US-231 N/US-60 BYP E via Exit 70A toward Hawesville, Take next Exit-18 to KY-54, turn RIGHT toward Whitesville/Leitchfield. Go 5.4 miles on KY -54. Daviess County Fair Grounds is on the left



From Hopkinsville KY: Take Pennyriple Pkwy N. Take the Wendell H Ford Western Kentucky Parkway East exit, Exit 34A, toward Elizabethtown. Merge onto Wendell H Ford Western Kentucky Pkwy E. Merge onto William H Natcher Pkwy N via Exit 77B toward Owensboro. Merge onto US-231 N/US-60 BYP E via Exit 70A toward Hawesville. Take EXIT-18 to KY-54, turn RIGHT toward Whitesville/Leitchfield. Go 5.4 miles on KY -54. Daviess County Fair Grounds is on the left

From Elizabethtown KY: Take Wendell H Ford Western Kentucky Pkwy. Merge onto William H Natcher Pkwy N via Exit 77A toward Owensboro. Merge onto US-231 N/US-60 BYP E via EXIT 70A toward Hawesville. Take next EXIT-18 to KY-54, turn RIGHT toward Whitesville/Leitchfield. Go 5.4 miles on KY -54. Daviess County Fair Grounds is on the left

From Evansville, IN: Take US-41 South. Take Pennyriple Pkwy S.

Take the Audubon Parkway exit, EXIT 77, toward Owensboro. Take the Owensboro BY-PASS exit, EXIT 24A, toward US-60/East William H Natcher Parkway. Merge onto US-60 BYP E. Take EXIT-18 to KY-54, turn RIGHT toward Whitesville/Leitchfield. Go 5.4 miles on KY -54. Daviess County Fair Grounds is on the left

General Show Rules

1. This show will be governed by the Official ARBA Show Rules.
2. Good Showmanship and fair play will be the rule of the day.
3. The Executive Committee of RCRBA shall handle any arbitration and those decisions will be final.
4. Check-In from 6:30 to 8:00 AM (CST). Judging will start at 9AM (CST).
5. Carrying case show. Case bottoms MUST BE LEAK PROOF.
6. Sanctioned breeds will receive awards, per specialty club guidelines. All ARBA recognized breeds can compete for Best in Show.
7. Exhibitor's wishing to sponsor breed sanctions that are NOT already sanctioned must contact Keat Hor a minimum of 40 Days prior to the show date.
8. **NO DOGS ARE ALLOWED IN SHOWROOM.**
9. Parents allowing children to run amok in showroom will be asked to leave and entries forfeited.
10. RCRBA will not be responsible for any property loss due to accident or theft.
11. Accordance to KY State law, no sale animals under 8 weeks old are allowed. Violators will be asked to leave.
12. Submission of an entry in any show will confirm the exhibitor's acceptance of these rules.
