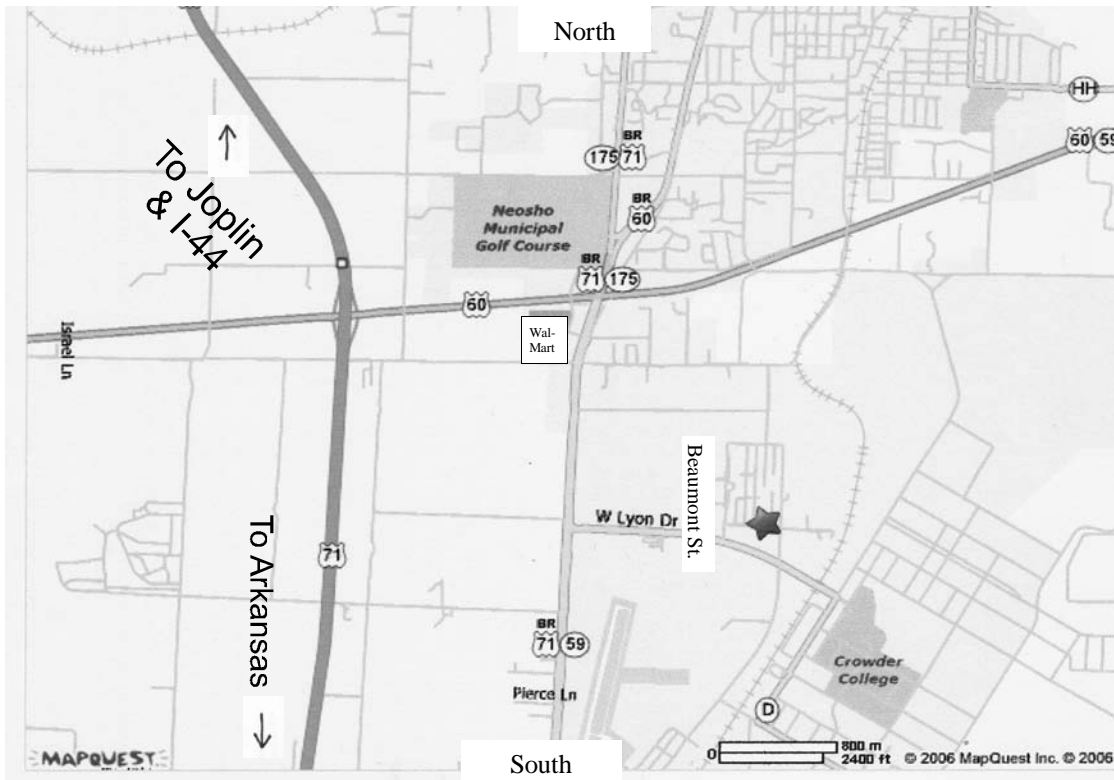

#### SWMHR Show Rules

1. This is an official ARBA and Missouri State Rabbit Producers Inc. sanctioned shows and will be governed by the latest show rules. Filing of an entry indicates acceptance of these rules.
2. Show Date: February 27, 2010. **SHOWROOM OPENS AT 6:00 A.M. SHOW STARTS PROMPTLY AT 8:30 A.M.**
3. All rabbits **MUST BE PERMANENTLY AND LEGIBLY EAR MARKED.**
4. **DAY OF SHOW ENTRY ONLY. ENTRY FEE: \$3.00 IF ENTERING ONE SHOW or \$5.00 IF ENTERING BOTH SHOWS PER RABBIT. FUR IS \$1.50 PER RABBIT PER SHOW.**  

**Make checks payable to SOUTHWEST MISSOURI HARE RAISERS (SWMHR).**
5. Each exhibitor must fill out their own entry forms and comment cards. Your entry form is the OFFICIAL entry. Entry forms and comment cards must match or animal will be disqualified.  
 Please use a separate form for show A and show B and mark which show, A or B.  
 Please use a separate form for Open and Youth entries and mark Open or Youth.  
**COMMENT CARDS MUST BE MARKED—OPEN FOR OPEN ENTRIES AND YOUTH FOR YOUTH ENTRIES. IN ADDITION, PLEASE MARK SHOW A or SHOW B.**  
 Comment cards will not be mailed. Please pick them up at the judging tables.
6. All rabbits must be entered in the name of the bonfide owner. Youth can not show the same rabbit in both open and youth shows.
7. **YOUTH MUST PUT YOUTH RABBITS ON THE JUDGING TABLE.**
8. Southwest Missouri Hare Raisers is not responsible for any loss from fire, thefts, accidents, death of rabbit or providential destruction during the show. Unruly children will not be tolerated.
9. The club reserves the right to add or substitute other judges.
10. Any animal showing signs or symptoms of disease will be removed from the showroom promptly.
11. Show reports will be mailed to each exhibitor after the show. Please make sure name, address and e-mail address is legible and correct. Comment cards will not be mailed. Pick them up as your animals leave the judging table.
12. SWMHR will sanction any breed of rabbit recognized by the ARBA for 2010 if 10 or more are shown in 2009. If 10 or more are not shown in any breed, the sanction will be dropped the following year.
13. Vendors must have permission from the superintendent to set up sales and must pay a fee of \$25.00 or equivalent in merchandise for the raffle.
14. This is a carrying cage show. Leak proof carriers will be required.
15. **SMOKING IS PROHIBITED IN THE BUILDING BY STATE AND LOCAL LAWS.**
